## VIII. Discussion Items:

- A. <u>Potential Cost-Saving Measure on Monthly Electric Expenses</u> Dan Koffman did a presentation on Tune Harmonics devices that hook up to electric panels to reduce heat, noise, monitor electric usage, would save 15% on electric costs.
- B. <u>Class Reunion Tours</u> Mr. Cocco gave 2 class reunion tours this month, he said they were fun, he loves to see the reactions of alumni.
- C. School Forest We are working on a Federal Grant from the U.S. Forest Service that would cover the cost of eliminating the autumn olive plant on 100 acres of our School Forest. It would be a 3-phase grant. 1<sup>st</sup> year harvest all the trees that we can, 2<sup>nd</sup> year Spray herbicide via helicopter, 3<sup>rd</sup> year plant new trees.
- D. <u>Permit Timelines</u> Sub permits are vital; these timelines must be followed. Mr. Cocco is working to assure that we obtain all the required permits for this school year.
- E. <u>Highway 41 School Zone Caution Lights</u> MI Department of Transportation will replace the current school zone caution lights in Carney. The new caution lights will be on 3 times during the school day.
- F. <u>School Resource Officer</u> The MC-ISD has proposed that we share a School Resource Officer with NCA & SAPS, the ISD would pay 50% and the three schools split the remaining 50%.
